# 1. Introduction

# 1.1. Background

Following the death of my father (Harold Dick Sewell) I wanted to investigate my family origins. My father had not been over-keen on discussing this, possibly due to his feelings about the death of his father, Harold, (during World War 1, a couple of months before he was born).

At his funeral I was presented with a copy of a family tree prepared by Ann Faulder which showed the descendents of Joseph Sewell Faulder, my father's grandfather. About the same time I received a similar tree prepared by Meriel Tuzee.




Figure 1 - Partial Family Tree of Joseph Sewell Faulder, showing those mentioned in the introduction

### 1.2. Initial objective

I had three initial objectives:

- 1. To find out a bit more about my paternal grandfather, and
- 2. To go further back up the Faulder family tree and as a minimum discover the source of the Sewell name that my father, and his grandfather (and others) shared.
- 3. To discover more about the various maternal lines.

This document is principally concerned with the second objective.

# 2. Approach

My approach to doing this followed the standard lines of:

- gathering what information is available within the family (and probably missing significant bits of information)
- searching on the internet
- going through physical records (particularly at Carlisle Record Office) partly to confirm some of the less reliable information on the internet and to access documents like wills.

I was guided by a free paperback published by the Independent (Colwell 2006) and by guides on the Internet (particularly Ancestry.co.uk and the BBC Family History website).

# 3. Initial Findings

The initial approach almost answered all my questions. Unfortunately it gave me more answers than I had questions.

Within my father's papers I found a note from an Edward Faulder<sup>1</sup> (2002) to Meriel Tuzee about Joseph Sewell Faulder's father (William), mother (Ann

Sewell), siblings, paternal grand parents (Robert and Catherine Blaylock) and paternal great grand parents (Robert and Ann).

On the Internet I found a Faulder Family Tree (Helby 2006a)<sup>2</sup> which reported Joseph Sewell as being the son of William Faulder (married to Ann Sewell), the son of Joseph Faulder and Susannah Bell of Carlisle with ancestors going back to a John Faulder who died in 1700.

# 4. Initial Resolution

## 4.1. Christening Records for William Faulder




Figure 2 - Christening Record of a William Faulder at Beaumont 12 February 1804 (from microfilm of Parish Records kept at Carlisle Record Office)

At Carlisle Record Office I tried to investigate both these alternative parentages for William Faulder. I could only find parish records of a Christening of William Faulder in Beaumont on 12 February 1804 (figure 2 below). The parentage details match those in Edward Faulder's note. This however is not necessarily corroborating evidence - I have probably just found the same record as Edward found. It is interesting to note that the mother is described as "Catherine his wife (Late Faulder) heretofore Blaylock", which would imply that she had previously been named Faulder and before that Blaylock.

I could not find a corresponding record for a Christening of a William Faulder in Carlisle in 1804 (the recorded date on the Helby sourced tree is 22 December 2007). Apart from the IGI<sup>3</sup>, I also searched the Bishop's Transcripts for both St Mary Carlisle and St Cuthbert Carlisle, and the microfilm copy of the parish registers for those two parishes. I did, however, find the details of the marriage of Joseph Faulder to Susannah Bell. As I could not find details of any of their children (5 according to the Helby Tree), I wonder whether they moved out of Carlisle and I have consequently been looking in the wrong parishes.

# 4.2. Robert Faulder(s) married to Catherine Blaylock

Edward Faulder's note recorded that Catherine Blaylock married two Robert Faulders. It seemed logical to investigate this remarkable co-incidence. Investigation of parish records shows this to have been the case.

#### 4.2.1. Catherine Blaylock

Katherine Blacklock was christened on 25 July 1773 at Beaumont (Figure 3 below). The record is not easy to read but looks as if it originally recorded the diminutive "Katy" as the Christian name, with the fuller "Katherine" written above. The surnames Blacklock, Blaiklock and Blaylock seem to be interchangeable at this time. The lack of other more fitting alternatives make me confident that this is the woman who eventually married into the Faulder family.

#### 4.2.2. Marriage of Catherine Blaylock to Robert Faulder (No.1)


Figure 4 - Marriage Record of a Katy Blaylock to a Robert Faulder at Kirklinton 18 June 1794 (from microfilm of Parish Records kept at Carlisle Record Office)

The variation in Christian name and Surname is potentially important as a search for marriage records shows a marriage of a Katy Blaylock (of Wholeshields) in Kirklinton to a Robert Faulder (of St Mary's Carlisle) (figure 4 below).

The witnesses included William Blaylock (possibly her father), Beety Blaylock and Samuel Coleman.

#### 4.2.3. Aside: Geography and possible contradictions

The location of the marriage is a bit puzzling as Kirklinton is on the opposite side of the Eden from Beaumont (Katherine/Katy's place of Christening).

"Wholeshields" is probably Holeshields, a farmstead near Heathersgill, just to the east of Kirklinton. (Figure 5 below, shows the area concerned)

John Blaylock (2007) has confirmed to me that the Holeshields area was the home area for three different Blaylock families. One might have supposed that Catherine was baptised in Beaumont because that is where her mother (Elizabeth) came from. However it looks as if Elizabeth is actually Elizabeth James of Stanwix (East side of the Eden). Her father William, however, may have been born in Beaumont. Unless she decided to be married from a more distant relative's home (the marriage was by licence - which could imply it was not her normal home parish), this does not explain why Catherine is shown as coming from Holeshields, which raises a slight doubt as to whether I have identified the right women. There is one other Catherine Blaylock in the records (Christening: 27 OCT 1821 Kirk Andrews Upon Esk), but her dates do not match later records.

As a final aside it should be noted that even though the Eden is tidal near Beaumont, this should not be seen as a barrier between the two banks.

During this time it was possible to ford the River Eden at Rockcliff Wath (see figure 6 above) and apparently (according to one of the archivists at Carlisle) it was known for cattle to be driven across the river using this ford. There was another ford a little upstream at Doudle near Cargo. It is therefore not appropriate to think of Beaumont and Kirklinton as being geographically remote.

#### 4.2.4. Death of Robert Faulder (No. 1)

Robert Faulder (No. 1) died intestate and Letters of Administration were granted to his widow, Catherine, on 23 March 1799 (Figure 7 below).

AT Cartisle March 2 3? -ON which day appeared perfonally Catherine Fander . and alledged that Robert Francher late of Beaugeout \_ \_ in the parish of Beaum out and diocele of Carlille, Gentlaman decealed, died inteflate, without making any will, (fo far as Me doth know or believe.) That he the said latherine Raulder is the Carsful ladow and Relect of the faid deceafed Wherefore Jice prayed letters of administration of all and fingular the goods, chattels, and credits of the faid deceafed, to be committed and granted to der, the faid latterine Faulder \_\_\_\_ on her giving good and futicient fecurity in that behalf.

The fellow bounders<sup>4</sup> named on the bond were: William Blaylock of Holeshield and Arthur Graham of KirkAndrews on Eden. One of the wedding witnesses was a William Blaylock. Catherine's father was a William Blaylock.

Catherine and Robert had at least three children: Mary (christened March 1795), Elizabeth (c May 1797) and Robert (c June 1799). All would have been minors at the time of their father's death and it is assumed that they stayed under the care of their mother. It would appear that their family home at this stage was Beaumont.

#### 4.2.5. Marriage of Catherine to Robert Faulder (No.2)

Catherine was remarried in August 1803 in Beaumont to a Robert Faulder of Beaumont (see Figure 8 below). She is described as "Catherine Faulder", a widow, but her given age matches other records and she signs the register "Catherine Faulder, late Faulder heretofore Blaylock". This is, therefore, highly likely to be the same Catherine as previously married Robert Faulder (No. 1).

I have not yet identified exactly who was the Isabella Faulder who was a witness to this marriage.<sup>5</sup> John Hodgson is a name that also occurs elsewhere.

Catherine had at least two children by this relationship; William (christened February 1804) and Thomas (c September 1806). Thomas died in 1807 and

William is the father of at least 10 including Isabella, Robert, Joseph Sewell and John.

#### 4.2.6. Death of Catherine Faulder

Catherine died intestate in 1809 and is buried at Beaumont (Figure 9 below).

Not only did she die intestate, but she also died before completing the administration of her first husband's estate.

Letters of Administration were granted to her widower in respect of her estate (see figure 10 below) in February 1813 - four years after her death. The additional bounders were John Robinson and William Hodgson. William Hodgson may be related to John Hodgson the witness to their marriage.

Wherefore he prayed letters of administration of all and singular the goods, chattels, and credits of the said deceased, to be committed and granted to hun the said Mubert hauld en --on his giving good and sufficient security in that behalf

It is presumed that the surviving child of the second marriage (William) stayed in the care of his father. However the children of the first marriage (still minors) seem to have been put in the care of Samuel Coleman (of "Glasgow, North Britain") by order of the Carlisle Diocesan Court on 13 May 1811 (see figure 11 below).

This Samuel Colman may be the same Samuel Colman as witnessed Catherine's first marriage in 1794 (figure 4). In the court declaration (Administration De Bonis Non<sup>6</sup>) Samuel is named as Catherine's nephew and cousin and next of kin to the three children of the first marriage.

The other bounders to the administration order where William Hodgson and John Connell. The William Hodgson may be the same bounder as for the Administration of Catherine Faulder.




Figure 12 - Letters of Tuition (part of) granted to Samuel Coleman in respect of Robert Faulder, son of Robert Faulder (descd) (Photograph of original kept at Carlisle Record Office)

The 21<sup>st</sup> century view might be that we would expect the minor children of the first marriage to stay with their step-father (Robert No.2) and stepbrother (William) following the death of their mother. Whilst we know that Samuel Coleman was given responsibility for them (the Administration De Bonis Non does not use the word 'guardianship') and that he lived in Glasgow, we cannot prove that he took the children back to Glasgow; it is possible that he left them with their step-father. This may be the case because in July 1811, Samuel Coleman is also appointed (by Carlisle Court) Tutor, Curator and Guardian of the minor son Robert (see figure 12 below), which would seem to be a more extensive taking-charge of the minor son.

William Hodgson (of Carlisle) is a bounder to these letters of tuition; the wording would imply that he was Samuel Coleman's duly authorised attorney.

#### 4.3. Death of Robert Faulder, Son of Robert Faulder (No.1)

Robert Faulder, the son of Catherine and her first husband, died on 8<sup>th</sup> April 1863. On 1<sup>st</sup> October 1863 probate was granted on his will of 3<sup>rd</sup> October 1854 (see figure 13 below).

In the will he makes specific reference to his half brother William Faulder of Brisco Hall both as a beneficiary and, with William Robinson and his wife Mary, as a Trustee of the will (and guardians of his children during their minorities). In the 1851 Census, William Faulder (father of Joseph Sewell et al.) is listed as being head of household at Brisco<sup>7</sup>, in the 1861 Census his Brisco address is not specified, but in the 1871 Census he is listed as head of household at Brisco Hall.

#### 4.4. Summary

The above will of Robert Faulder makes specific reference to William Faulder of Brisco having a half-brother. We know (from family knowledge confirmed by census records) that William Faulder of Brisco was the father

of Joseph Sewell Faulder (and three other children who had issue: Isabella, John and Robert).

We can find christening records that indicate that William Faulder's parents were probably a Robert Faulder and "Catherine (Late Faulder) heretofore Blaylock".

We can find records of Katy Blaylock being married to Robert Faulder and a widow "Catherine Faulder, late Faulder heretofore Blaylock" being married to a Robert Faulder.

Court Records tell us that Catherine and Robert Faulder had a son Robert.

Excepting the possibility of other people of the same name not being in the records for Cumberland, it would appear that William Faulder was the son of Robert and Catherine and that she had previously had another family by another Robert Faulder. This confirms Edward Faulder's note to Meriel Tuzee.

# 5. The half family

Having established that Robert Faulder was William Faulder's half-brother, the question can be raised about the half-family that was Robert (no.1)'s descendants.

Using census records and a limited amount of speculation (usually based on there being no alternative explanation in the records) allowed the development of a partial family tree.

Searching in Ancestry.co.uk then found a matching fragment which lead to me contacting an Eleanor Hodgson (who turns out to be my fourth halfcousin) who confirmed that Catherine Blaylock and her husband Robert "the dumb" Faulder were ancestors. She did not know of the other half family but had a query as to who was Joseph Sewell Faulder - named as an executor in the will of William Jackson, her Great Grand-father.

Appendix 1 shows in outline what I know of the half-family (some details of living people obscured).

In section 2 (Approach), I mentioned using family sources for information (and missing significant bits). I now note in a letter sent to me in December by Susan Helby's grandmother, Kathleen Scott Helby (2006b), that she knew of another cousin "by marriage", Nellie Walker - a doctor's widow in Newcastle. She is almost certainly Mary Eleanor Walker (née Pattinson 1859-1942), widow of Thomas Hatfield Walker (a senior doctor in Newcastle) and a member of the half family (see the summary of the half family in appendix 1). This does mean that the two sides of the family knew of each other in recent memory - and I have not been asking the right people the right questions! Eleanor Hodgson (see above) has lent me the accounts of the Executorship of Mary Eleanor Walker (1943) and this has helped confirm many details in appendix 1.

# 6. The Ancestors of Catherine Blaylock and her Husbands

I started wanting to find a Faulder ancestor; I finished with an ancestor, Robert Faulder married to Catherine Blaylock, another Robert Faulder who had also been married to Catherine Blaylock and a Joseph Faulder married to a Susannah Bell.

One then wonders if all these Faulders might be related. To do this it is necessary to search parish records and wills and letters of administration. This is still work in progress.

#### 6.1. Aside: Surname Variation

Gertler (All)

To complicate matters, prior to the mid 1800s, the spelling of "Faulder" varied - with "Falder" being a common variation. "Folder" is comparatively rare. A swift analysis of the IGI Christening records for Cumberland shows that Faulder and Falder are the most common.




Figure 14 - Distribution of Surname Variations in Cumberland (per IGI)

The variation arises probably due to differing levels of literacy so clergymen when making entries in parish registers probably have to guess the spelling.

It also shows that between about 1700 and 1860 there was a general growth in the number of christenings. After that the number drops dramatically - possibly reflecting migration to other parts of the UK and other parts of the world. The introduction of the registration system in 1837 may also have contributed to the decline in Christenings recorded in the IGI.

### 6.2. Ancestors of Robert Faulder (No.1)

Robert, the first husband of Catherine, was christened 30 April 1746, the son of William Faulder and Mary. The will of William refers to three minor children (Jane, Mary and Robert) and to his father in law, Robert Falder, as one of his executors. A family tree in the possession of Eleanor Hodgson (Hodgson 2007a) indicates that Mary, William's wife, was also his cousin - which might explain the father-in-law's surname.

I have not yet found any record of William and Mary's common ancestor. William's parents would appear to be William Faulder and Jane Hewitt, whilst Mary's parents would appear to be Robert Falder ("the elder") and Isabelala (sic).

Further searching of wills and parish records, together with examination of gravestones, will help to firm up these details with details of other life events (e.g. Christenings, Marriages, Burials and Probate).

#### 6.3. Ancestors of Robert Faulder (No.2)

Edward Faulder's note indicates that the father of Robert (the second husband of Catherine Blaylock) was another Robert who was married to an Ann.

The Beaumont Parish records show a Robert Falder (likely to be the second husband of Catherine - due to lack of alternative records) being christened on 22 December 1770 (see figure 16 - below).

2.2.2. Robert Be Son of Rediert & some Faller of Brounant

Searching nearby parish records reveals (in Burgh by Sands in 1774) the only possible marriage of a Robert Falder to an Ann(e). (Note that this record is not the actual register.)

It is likely (due again to lack of alternative records in the immediate area) that Robert Falder and Anne Jackson are the paternal grand-parents of William Faulder (of Brisco). William named his eldest son 'William

Jackson Faulder' (1836-1853) - possibly reflecting the then widespread practice of using maternal surnames as Christian names.

A will (see figure 17 - below) of Robert Faulder of December 1778 (proved on 27<sup>th</sup> February 1779) names his wife Ann as trustee and guardian of his two minor sons (one named elsewhere in the will as Robert, but the other unnamed). The will also names two daughters; Mary (Newby) and Ann (Faulder).

### 6.4. Ancestors of Catherine Blaylock

Catherine's christening record (figure 3 - above) give her parents as William Blaylock and his wife Elizabeth. Records of the most likely marriage (in Stanwix 10 August 1765) indicate that she was probably Elizabeth James.

Other Christening records indicates that Catherine probably had four siblings: George (b 1771), Thomas (b 1775), Betty (b 1778) and Nanny (1780-1781). A "Beety" (together with a William) Blaylock were witnesses to Catherine's first marriage; she might be the sister Betty - or her mother.

This Blaylock family does not appear to be the clock-making family of Longtown.

#### 6.5. Ancestors of Joseph Faulder and Susannah Bell

Susan Helby (2006) details the paternal line of Joseph Faulder. He was married to Susannah Bell in St Cuthbert's Carlisle on 15 January 1797 (5 children including a William), and his parents, John Faulder and Margaret Pool were married in Sebergham on 3 April 1748 and they had a large family (possibly 12).

John's father is given as another John, his grandfather is listed as a John or William, and his great grandfather is given as another John (married to an Isabella).

A number of overseas contacts via the internet have indicated a link with Faulder's of Sebergham.

# 7. Conclusion

From the records discovered I am confident that the ancestors suggested by Edward Faulder (i.e. Robert and Catherine) are my ancestors. This is particularly supported by marriage records and the will of a Robert Faulder who names his half-brother, William Faulder of Brisco.

Further investigation of parish records (prior to about 1850) and wills may help relate various Faulder families (particularly the two that married Catherine Blaylock). In addition a review of Census details (1841-1901) for Cumberland may establish distinct families (allowing the application of a process of elimination).
